Super Fans Contest – Beneva Game

1. CONTEST ORGANIZER

The Super Fans Contest – Beneva Game is organized by Beneva Inc. ("Beneva" or the "Contest Organizer").

2. CONTEST PERIOD

The contest will be held in Quebec from 10:30 a.m. to 1:20 p.m. ET on October 14, 2024 (the "Contest Period").

3. ELIGIBILITY CONDITIONS

To enter, participants must:

- Be a resident of the province of Quebec
- Be age 18 or over on October 14, 2024

4. HOW TO ENTER

Participation in this contest is free, with no purchase necessary.

To enter the contest, individuals must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations stated in these rules, there is only one way to enter during the Contest Period:

6. SPECIFIC PRIZE CONDITIONS

CONTEST RULES

The prize is non-cashable and cannot be transferred, assigned or exchanged.

7. DRAW

- **7.1** The prize will be drawn at random among eligible entries. The draw will be held at 1:25 p.m. ET on October 14, 2024, in the presence of a Beneva Inc. employee at the Percival Molson Memorial Stadium at 475 avenue des Pins Ouest, Montreal QC H2W 1S4.
- **7.2** The odds of winning depend on the number of eligible entries received during the Contest Period.
- **7.3** Beneva reserves the right to disqualify persons or cancel entries that are not in compliance with contest rules.

8. PARTICIPATION LIMITATIONS AND EXCLUSIONS

- **8.1** The number of entries per person is limited, as described in section 4 of these contest rules.
- **8.2** Employees, officers, mandataries, directors, administrators and representatives of Beneva Inc. and its affiliated companies, and individuals residing at the same address, may not enter the contest.

9. GENERAL CONDITIONS

- **9.1** To be declared a winner, contest participants selected at random must:

 - Correctly and without assistance, answer a timed mathematical skill-testing question.
